The monthly prices are binding. No rights can be derived from the amount of hours and hourly rates. Calculation differences due to rounding and interim price and /- or hour alterations are possible.



Summary of contract terms

- Op Stoom applies a cancellation period of 1 month for all services (including partial cancellation). Termination of the agreement can be done on any given day of the month via letter or e-mail. If you cancelled the agreement during the second half of the month, the financial processing of the cancellation will be done the following month due to the direct debit system. For example: if you cancel the after school care on February 17th, the full monthly amount for March will be charged via direct debit. At the end of March you will receive a credit invoice and refund of the excess amount paid.
- Switching a day of after school care is possible within two weeks depending on availability.
- All payments need to be made by direct debit.
- All fixed costs are charged in advance and on a monthly basis. Other costs such as extra days of after school care will be charged immediately after invoicing.
- The invoice amount is only valid if the payment is received on the due date. Payments received after the due date will have an increase of 1% per calendar month with a minimum of € 10,- per payment reminder.
- The invoice amount is binding during a split invoicing period.
- Invoices are published in 'Mijn Op Stoom'. Interim price alterations are sent exclusively by e-mail.
- A one-time contract fee of € 17,50 is required per child.

Good to know: How much benefit will you receive?

Each year the government determines the maximum subsidized hourly rate. You will receive benefits according to this rate. For 2017 the maximum eligible hourly rate for after school care is € 6,69 per hour. The following table shows you what percentage of the gross costs of after school care is refunded through the child care allowance, according to your income.
